### PREFACE

The Myanma Port Authority, as an incumbent authority and a facilitator of the port industry in Myanmar, periodically reviews and revises the Tariff and Dues for all ports of Myanmar. The Tariff and Dues expressed in this book is effective on 22<sup>nd</sup> September 2022.

Charges are classified into four categories, 1) charges on vessels, 2) charges on cargoes, 3) miscellaneous charges, and 4) charges on containers. General explanation for these charges is mentioned separately.

Port users are kindly requested to contact the Deputy General Manager (Traffic Department) for Yangon Port and respective Chief Port Officers for the Outports, for further information associated with the Tariff and Dues.

# **GENERAL EXPLANATION**

## The Authority/the Port Authority

 The Authority or the Port Authority, hereinafter used in this book, refers to the Myanma Port Authority.

### Charging Base and Unit

- 2. <u>Charges on Vessels:</u> These charges are calculated based on gross tonnage of the vessels.
- 3. <u>Charges on Cargoes:</u> These charges are calculated based on weight or measurement by which freight has been collected, but for the avoidance of doubt, the Deputy General Manager (Traffic) reserves the right to apply the higher one of the two rates.
- 4. **<u>G.R.T</u>**: **G.R.T** means Gross Registered Tonnage of the vessel as stated in the ship registration.
- 5. <u>**Tonne:**</u> Tonne means one metric tonne of 1000 kilograms or one cubic meter.

### Working Hours

- 6. <u>Shift:</u> Shift means an 8-hour working shift. The ports normally operate on a 2–shift basis and working hours of the shifts are as follows:
  - (a) Day shift 0800 hours to 1600 hours
  - (b) Night shift 2000 hours to 0400 hours
- 7. **Overtime Work:** Overtime Work is the work being carried out for the periods between Day Shift and Night Shift, for which arrangements may be made on request.
- 8. This tariff is subject to change with or without notice.

# **Currency Surcharge**

- 9. Based on the currency fluctuation of the Myanmar Kyat, a certain percentage of the charges on the following prescribed rates will be levied as the Currency Surcharge on all vessels using the ports, as and when required with prior notice:
  - (a) Port Dues
  - (b) Light Dues
  - (c) Pilotage Charges
  - (d) Berthing Charges
  - (e) Stevedoring Charges
  - (f) Conservancy Charges on export only
  - (g) Vessel's Hire and Salvage Charges
  - (h) Container Charges
  - (i) Other Dues and Charges levied and settled in Foreign Currencies.

### NOTE

- 1. Vessels belonging to the MYANMAR DEFENCE SERVICES, pleasure yachts, or any vessels, which have already left from any port of MYANMAR, but compelled to re-enter the port by stress of weather or in consequences of having any damage, are exempted.
- 2. Capacity means the capacity in tonnes of the inland vessels as stated in the license issued by the relevant government authorities.

Light dues are levied on all vessels entering to or departing from any port of MYANMAR for every 30-day period, until the date vessels depart for the next ports of other countries.

# 3. PILOTAGE CHARGES

Pilotage service is compulsory for all vessels of 500 GRT and above. Pilotage Charges will be levied based on the gross tonnage and the higher one among the two types of draft, i.e., forward draft and after draft of vessels.

- 1. Charges at the defined rates shall be leviable for pilotage from the Outer Station to any place within the harbour limits.
- 2. An additional charge of 50 % will be levied for any halt outside the harbour limits enroute for period in excess of six hours to serve the vessel's convenience.
- 3. An additional charge 15 % of inward/outward pilotage charges will be levied for all movements (from Pilot Station to Yangon Port, and Vice Versa) commencing or ending at any period between sun-set and sun-rise. An Additional charge of 7.5 % of outward pilotage charges (Base on Draft, GRT, and LOA) will be levied for all movement within harbour limits.
- 4. For the purposes of pilotage charge, vessels including vessels in tow (such as barge) and towing-craft vessels not exceeding 150 tons GRT, both are leviable. For towing-craft vessels exceeding 150 tons GRT, the defined rate shall be increased by 30 %.

In order to ensure that all ports are uniform in the reduction of such delay fees, from 9-4-2020 until the day of product removal, only the days in port will be calculated and collected at the new reduced rate, and the period up to 8-4-2020 will be calculated and charged at the old rate only.

### NOTE

- The normal free time allowed for the removal of the cargoes from the Authority's wharves is 72 hours, excluding the sanctioned holidays, after the final discharge of the vessel is completed.

In the latter alternative, the master or owner will be allowed two clear days after the completion of the vessel's discharge in which to sort and make over the goods without extra payment (demurrage thereafter being chargeable according to the prescribed scale of charges for undelivered cargo), and provided all documents necessary for obtaining delivery have been presented before completion of the vessel's discharge, and the goods have been made over to the Deputy General Manager(Traffic)within the aforesaid period, the consignee or consignees shall be allowed a further two clear days within which they may take delivery without incurring extra charges.

## **CONTAINER CHARGES**

#### **Explanation**

- 1. F.C.L Container; The F.C.L (Full Container Load) Container means: -
  - (a) A loaded container discharged from a vessel for direct delivery or discharged form a vessel, moved and stored at the stacking area for direct delivery: or
  - (b) A loaded container received for direct shipment or received and stored at the stacking area for direct shipment.
- 2. L.C.L Container: The L.C.L (Less than Container Load) container means: -
  - (a) A loaded container discharged form a vessel, moved and stored at the stacking area (or subsequently removed to the Container Freight Station) Where the containers are stripped for delivery (and the empty container is to be removed back to stacking area, if stripping operation is made at Container Freight Station); or
  - (b) A container into which the content is stuffed at the stacking area or at the Container Freight Station for Subsequent shipment as a loaded container.
- 3. T.E.U : T.E.U means twenty-foot equivalent unit or twenty-foot containers as set out in the regulations of the International Standards Organization (I.S.O)

#### **Application of Container Tariff**

4. The application of this container tariff is subject to the following conditions:

- (a) This container tariff shall apply to I.S.O Standard Containers only and special quotations will be made for all non-standard containers.
- (b) This container tariff shall be valid only for the container to be discharge or loaded by self-sustaining ships and special quotations will be made for containers to be discharged or loaded by the use of heavy lift cranes.
- (c) Special quotations will be made for reefer containers and other specialized containers.
